The Vice-President, Research and Francophone Affairs, invites applications for a **Research Chair in Occupational Safety and Health**. This **tenure-track or tenured appointment** at the rank of Associate Professor or Professor (dependent on level of experience) will begin on **July 1, 2014**.

The successful applicant will be expected to contribute to the ongoing development of the **Centre for Research in Occupational Safety and Health (CROSH)** at Laurentian University and lead research through CROSH. The applicant will also be required to contribute to teaching (primarily at the graduate level) in an appropriate department (dependent on his/her expertise and previous teaching experience).

The successful candidate will be expected to build a research program relevant to priority research areas in occupational health and safety for northern Ontario workers and industry. Working closely with the Director, Executive Committee and Advisory Board, he/she will also be expected to develop collaborative research relationships with existing CROSH research supporters (including but not limited to, United Steel Workers of America; Canadian Auto Workers; Ontario Nurses Association; Vale; DMC Mining; Health Science North; Workplace Safety North; Occupational Health Clinics for Ontario Workers; Workers' Health and Safety Centre; Ministry of Natural Resources; Ministry of Labour; City of Greater Sudbury) and encouraged to develop new research partnerships with labour, management and/or related government agencies in occupational safety and health.

Applicants must have a Ph.D.* in an Occupational Safety and Health field, with demonstrated excellence in research and grant funding, a history of graduate student supervision, and graduate teaching experience. Successful applicants will also have demonstrated leadership and management skills. Candidates should submit a statement of current and prospective research, a curriculum vitae, and the names of three references. *(In exceptional cases other relevant qualifications may be considered if supported by a strong research and academic record in occupational safety and health).
